- Mr Reeves updated the committee members on the operations of the Parks and Gardens Department;
  - Rejuvenation of the Recreational Grounds is commencing, this includes; scalping the field for any foreign objects, cutting the grass right back, topdressing the wheelruts, replacing sprays, fertilising and continual watering. The current rainfall has benefited the sub soil condition; therefore, the fields condition is holding up quite well given the recent event.
  - Continual street footpath maintenance
  - Tree mounds will be refurbished when works is limited
- Ms Gillies suggested planting additional trees on the western side of the lawn cemetery.
  - Mr Reeves noted that his Manager has submitted a request to the next Budget Meeting for an extension of the lawn cemetery.
  - Cr Baskett noted that the garden in the middle of the lawn cemetery with the large gum trees is effective.
- Mrs Stephens commented on the bunding around the tree mounds and the cracks in the mounds letting water away.
- Cr Sale asked the group to let her know of any suggestions they have for Shire Beautification Projects, so they can be taken to the next Budget Meeting.
